Dear Member,

The Rancho Santa Fe Association wants to bring you up to date on the process regarding the Santa Fe Irrigation District's proposed water rate increases and how you may protest the rate increase.

At the September Santa Fe Irrigation District Board meeting, SFID voted 3 to 2 to continue the process to approve a new rate structure. Details of the proposed rate increases were mailed to residents by SFID on October 1, 2018. (To view the document, please see the RSF Association website at *www.rsfassociation.org*.) The proposed two-tier structure eliminates the extremely high current tier 4 rates that many residents in our area pay. Additionally, the new tier 1 proposal collapses the first two tiers in the existing rates into a new tier 1. As a result, parcels that are charged the current tier 4 water rates should see some pricing relief, but not as much as we believe they can be with a more equitable solution.

You may voice your opposition to the rate increase by submitting a protest vote, labeled Proposition 218, by **November 15, 2018**, the date of the scheduled SFID Public Hearing. For the protest to be successful, at least 50 percent of ratepayers must file a protest.

To participate in the protest vote, please complete and return the attached form in person or by mail to either the Association or SFID. Protests submitted via e-mail or other electronic means <u>will not</u> be accepted as a valid written protest. Please return the original protest form by Thursday, November 15, 2018, to either the SFID or the RSF Association office. (See the attached protest vote form for mailing addresses or hand-delivery.)
